The social security number is not required when you apply on behalf of a foster child or you list a SNAP, Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number for your child or other (FDPIR) identifier or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced-price meals, and for administration and enforcement of the Program.

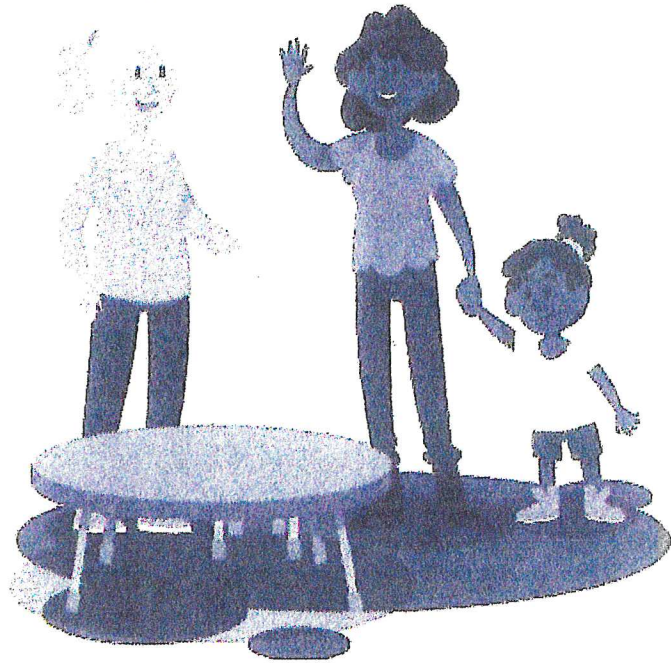

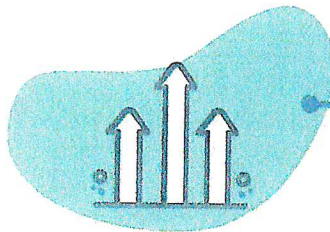
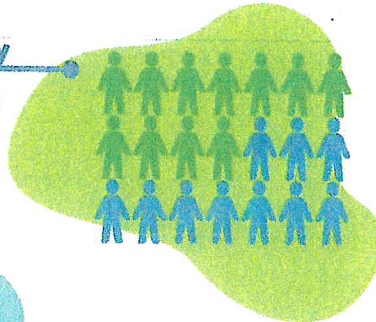
CAPS is EXPANDING to serve **10,000** additional children.

To help make more families eligible, CAPS income limits are increasing effective November 1, 2021.

Income at Initial Eligibility

The income eligibility limit has increased by **70%.**

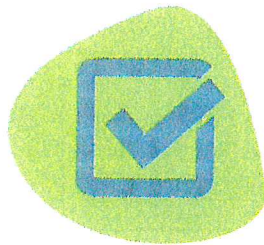
For a family of 4, the income eligibility limit has increased from **\$42,426** to **\$72,124.**



Very Low Income Priority Group

The income limit to qualify for "Very Low Income" priority group has **TRIPLED.**

For a family of 4, the very low income threshold has increased from **\$13,250** to **\$39,750.**

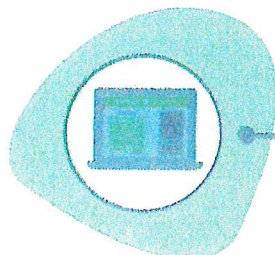

WHO IS ELIGIBLE?

- A pregnant woman
- A breastfeeding woman
- A woman who has recently been pregnant
- An infant or a child less than 5 years old

SERVICES PROVIDED:

- Nutritious foods
- Nutrition counseling
- Breast feeding support
- Health care referral

TO BE ELIGIBLE, YOU MUST ALSO:

- Have a low or moderate income
AND
- Have a special need that can be helped by WIC foods and nutrition counseling

APPROVED WIC FOODS:

- Milk, cheese, eggs, cereals, peanut butter, fruit or vegetable juices, dry beans or peas, iron fortified formula

YOU DO NOT HAVE TO BE ON PUBLIC ASSISTANCE TO APPLY.
